2. Registration

Registration Deadline for Main Exhibitors: April 30, 2019*

Form 1.10 (4 pages) must be submitted by each main exhibitor. Please fill out this form completely, stamp it with your company seal and sign it with a legally binding signature. If you wish to list brand names, please enter them on form 1.10.

Registration Deadline for Co-Exhibitors: June 30, 2019*

Co-exhibitors are registered by the main exhibitor using form 1.20.

3. Participation Fees

The minimum stand size is 16 sqm for a modular concept stand and 20 sqm for own stand construction. Depending on the date of registration, the stand area rental fee (plus VAT) is:

Per sqm of stand space, you will also be charged €100.00 for the Marketing Package, €10.5 0 for the flatrate energy fee and €0.60 for the AUMA fee. In addition, you will have to pay an exhibitor down payment for services. All prices are net prices and do not include legal VAT. In the case of own stand construction, the rental fee for stand areas does not include the cost of any structures.

Koelnmesse is entitled to collect an adequate down payment for the services provided at an event — e.g., electricity and water supplies, media services etc.

4. Modular Concept Stand

Be sure to take advantage of our offer and book a turnkey stand. Further information can be found in our modular concept stand booklet.

5. Construction Times

Construction period begins: Sunday, September 8, 2019, 8:00. Construction period ends: Wednesday, September 11, 2019, 7:00. Work that produces large amounts of dust must cease by 18:00 on Tuesday, September 10, 2019. All of the aisles must be completely clear by 18:00 on Tuesday, September 10, 2019. Upon request, Koelnmesse can permit stand construction to begin earlier. Early stand construction costs the following amounts per stand area:

From Friday Sept 6, 2019 €1,600.00 From Saturday Sept 7, 2019 € 800.00

The storage of material is also considered to be construction. The halls will be open around the clock during the construction period. For each violation the Koelnmesse is entitled to impose a penalty for breach of contract of up to €5,000.00. In general, vehicles will be granted access to the grounds until 17:00 on the last day of construction.

6. Dismantling Period

Dismantling Period begins:

Thursday, Sept 12, 2019 at 17:30

Dismantling Period ends:

Friday, Sept 13, 2019 at midnight

Upon request, Koelnmesse can permit the dismantling period to be extended until midnight on Saturday, September 14, 2019. This extension costs €800.00 per stand area. The storage of material is also considered to be dismantling.

The halls will be open around the clock during the dismantling period. Dismantling may not begin before 17:30 on September 12, 2019.



7. Stand Confirmation

Once your company has been accepted for participation, you will receive the stand confirmation in May 2019 at the earliest.

8. Technical Guidelines and Services

You will receive the technical guidelines together with the confirmation for your registration. Our entire range of services can be found at the Koelnmesse-Service-Portal. You will receive your login data as part of your stand confirmation.

9. Maximum Stand Height and Special Structures

The maximum permissible stand height is 3.0 m. Stands and structures that are higher than 3.0 m must be approved. Under no circumstances may they be more than 7.0 m high. The maximum permissible height includes all construction elements, advertising, lighting systems, traverses etc.

For a stand structure to be approved, the plans have to be sent via E-Mail to the DMEXCO Team (exhibitor@ dmexco.com) at least 8 weeks before the event begins. Lighting equipment may be suspended from the hall ceiling. Please note that for any objects hanging from the hall ceiling, neither the lighting equipment nor its mounts may be connected to the stand structure. If the stand structure is more than 3.0 m high, the exhibitor must either obtain his neighbors permission in writing or leave an open space at least 2.0 m wide along the closed stand boundaries to adjacent stand areas. Stand structures should be as transparent as possible. A maximum of only 30% of each open stand perimeters are allowed to be covered with closed wall elements.


The ceiling lights in the halls will be turned off and the skylights in the halls blacked out during the event.

10. Scale Drawings of Stands

Dimensioned stand ske tches will be sent to you together with your stand confirmation.

11. Withdrawal/Non-Participation

After the exhibitor has bindingly registered and been accepted for the event, it is no longer possible to release the company in question from the contractual relationship. However, the organizer can assent



12. Invoice

You will receive the invoice for the stand rental fee in June 2019 at the earliest. Please see the terms and conditions of payment listed in Section IV of the General Conditions of Participation.

13. Marketing Package

The Marketing Package is obligatory and includes a number of different services. Please see Section 3.1.2 of the Special Conditions of Participation.

14. Exhibitor Categories

The Marketing Package includes two exhibitor categories. You can order additional entries for €50.00 each.

15. Entry of Brand Name

In addition to publishing their company names online, exhibitors can also enter brand names there, which will be linked to the exhibitors profile.

A fee of €800.00 is charged for every brand name entered. Brands are registered using form 1.10.

16. Drawing up a new Invoice

The billing address entered in form 1.10 is definitive. You will be charged a fee if the invoice has to be drawn up again for reasons beyond Koelnmesse's control. A fee of €300.00 is charged for every new invoice.

17. Advertising

Outside the rented stand areas, exhibitors may only use the advertising possibilities offered by DMEXCO. No advertising materials and brochures of any kind may be distributed. In addition, exhibitors may not advertise in any way (including walking acts and promotional teams) outside their stand areas. Body painting, entertainers and scantily clad hostesses are not permitted.



18. Operation of WiFi

In order to avoid interferences with the operation of your own WiFi and the WiFi of other exhibitors, it is necessary to coordinate the WiFi networks centrally. This is only possible with homogenized infrastructure. Dedicated exhibitor WiFi networks and routers are therefor not allowed to be used. Please note Section 12 of the Special Conditions of Participation.

19. Stand Parties

Stand parties must be registered with Koelnmesse in advance. Events may not begin before DMEXCO ends (18:30) and must be over by 20:30. At that time the stand must be cleared as well. Please note Section 13 of the Special Conditions of Participation.

20. Stands may not be cleared early

The exposition stand has to be staffed until the official end of the event, violations hereof represent a serious breach of the Conditions of Participation and can be punished.

21. Conditions of Participation and Technical Guidelines

Koelnmesse is entitled to impose a penalty for breach of contract of up to €5,000.00 depending on the severity of the violation and/or to exclude the exhibitor from subsequent events.
